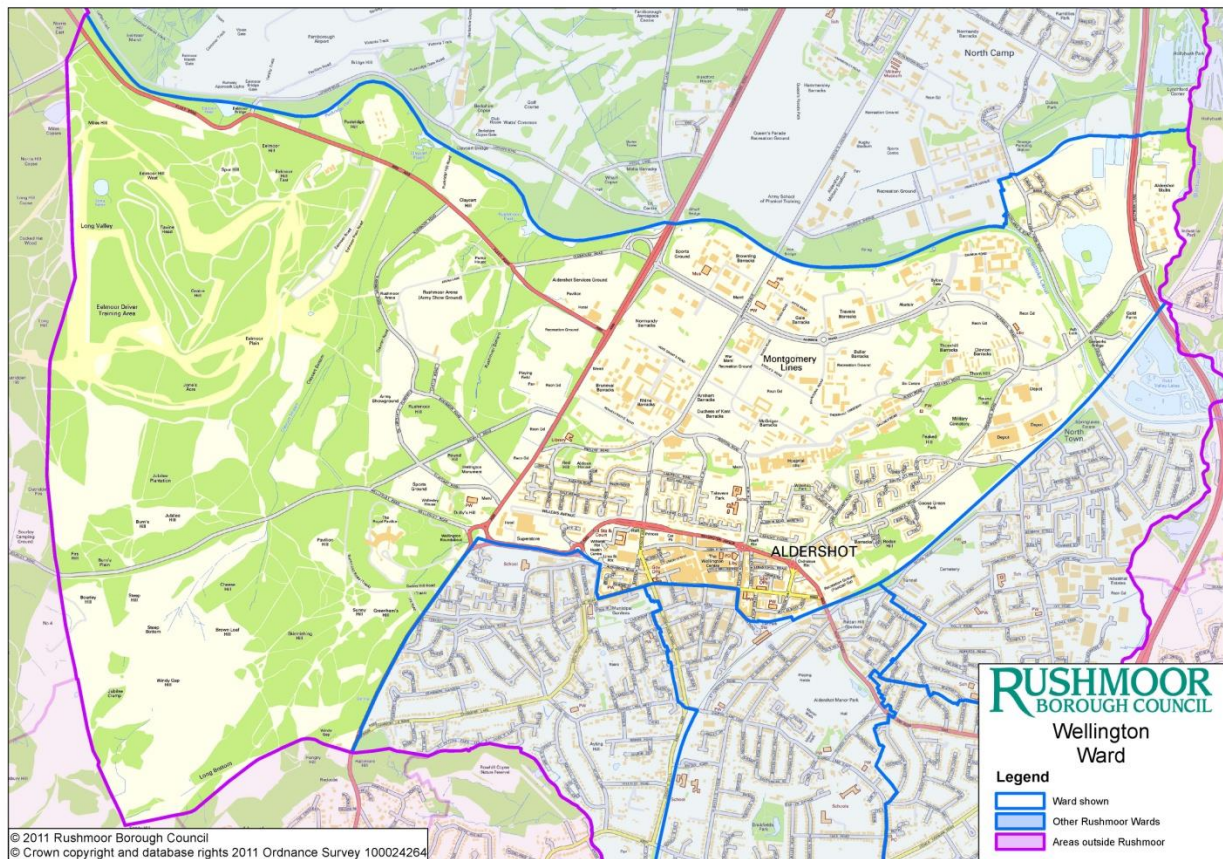

Wellington covers the military land south of the Basingstoke Canal, to the borough boundary in the west and the River Blackwater in the east. It includes Aldershot town centre.



Resident survey results

The last Rushmoor Borough Council residents' survey was carried out in 2018 with 1,046 surveys returned. The survey was an online survey and we know that 31 residents in Wellington ward filled in the survey. Below is a summary of the results for Wellington ward.

Satisfaction with Rushmoor (Aldershot and Farnborough) as a place to live (with 1 being very dissatisfied and 10 being very satisfied)

Respondents from Wellington ward have a lower satisfaction with Rushmoor as a place to live than the respondents from Aldershot and all respondents to the survey.

Top factor in making somewhere good to live

The top factor from the respondents from Wellington ward to making somewhere good to live is shopping facilities, which is the same as the respondents from Aldershot but different from all the respondents to the survey, who indicated that the level of crime was the top factor.

Top factor that needs improving in the local area

The top factor from the respondents from Wellington ward that needs improving the most is shopping facilities, this is the same as the respondents from Aldershot but different from all the respondents to the survey, who indicated that road and pavement repairs was the top factor.

Satisfaction with Rushmoor Borough Council (with 1 being very dissatisfied and 10 being very satisfied)

Respondents from Wellington ward have lower satisfaction with the council than the respondents from Aldershot and all the respondents to the survey.

Ward population and makeup 2011

The following data is from the 2011 Census

- **Population:** Wellington ward has a population of approximately 6,848, which accounts for about 7.3% of the population of Rushmoor.
- **Age:** Wellington has a younger population. Only 9.6% of Wellington ward is over 45, compared to 35.7% of Rushmoor as a whole. This is probably due to the Army housing within Wellington ward.

- **Religion:** There is a higher percentage of residents in Wellington ward who are Buddhist and Hindus, when compared to Rushmoor as a whole.

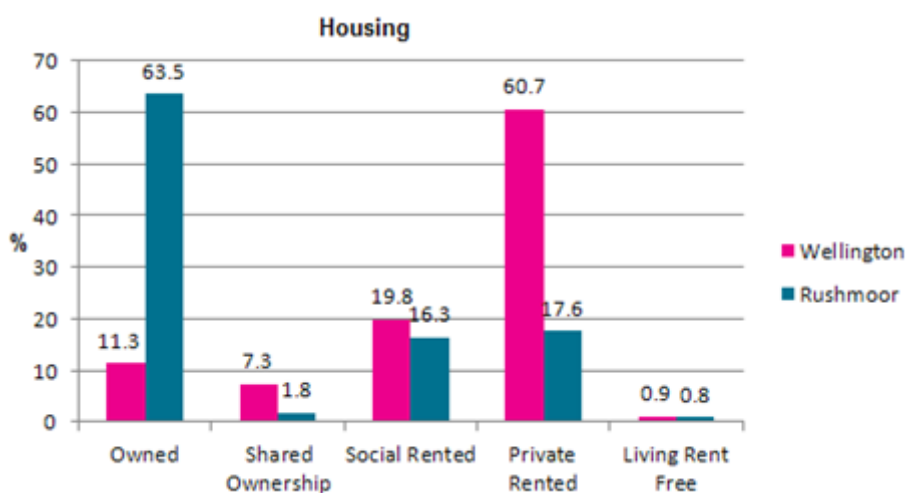

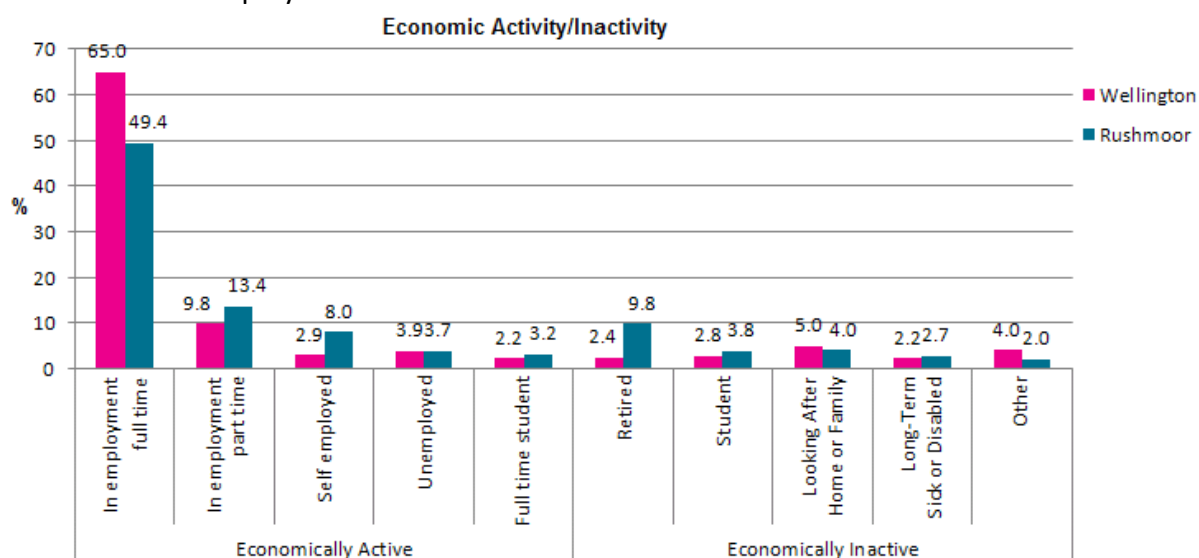
- **Housing:** Far fewer residents own their own homes and a much higher percentage of residents in Wellington rent privately (60.7%) this will include the Army housing in the ward.

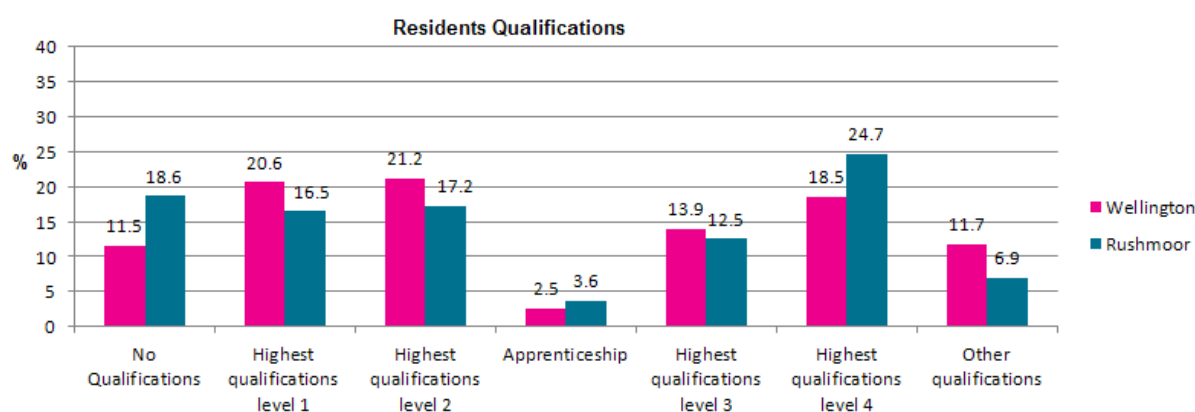
- **Economic Activity/Inactivity:** Wellington ward has a much higher percentage of full time workers, which may reflect the young population of the ward. There are

also fewer self employed and retired residents.

- **Qualifications:** A higher percentage of Wellington residents have qualifications in levels 1-3, and a lower percentage have no qualifications and the highest level of qualifications, when compared to Rushmoor as a whole.



Level 1 qualifications cover: 1-4 O Levels/CSE/GCSEs (any grades), Entry Level, Foundation Diploma, NVQ level 1, Foundation GNVQ, Basic/Essential Skills.

Level 2 qualifications cover: 5+ O Level (Passes)/CSEs (Grade 1)/GCSEs (Grades A*-C), School Certificate, 1 A Level/ 2-3 AS Levels/VCEs, Intermediate/Higher Diploma, Welsh Baccalaureate Intermediate Diploma, NVQ level 2, Intermediate GNVQ, City and Guilds Craft, BTEC First/General Diploma, RSA Diploma.

Level 3 Qualifications cover: 2+ A Levels/VCEs, 4+ AS Levels, Higher School Certificate, Progression/Advanced Diploma, Welsh Baccalaureate Advance Diploma, NVQ Level 3; Advanced GNVQ, City and Guilds Advanced Craft, ONC, OND, BTEC National, RSA Advanced Diploma.

Level 4 and above qualifications cover: Degree (BA, BSc), Higher Degree (MA, PhD, PGCE), NVQ Level 4-5, HNC, HND, RSA Higher Diploma, BTEC Higher level, Professional Qualifications (Teaching, Nursing, Accountancy).

Other Qualifications cover: Vocational/Work-related Qualifications, Foreign Qualifications(Not stated/ level unknown).

- **Health:** A much higher percentage of Wellington residents reported very good health, when compared to Rushmoor as a whole.

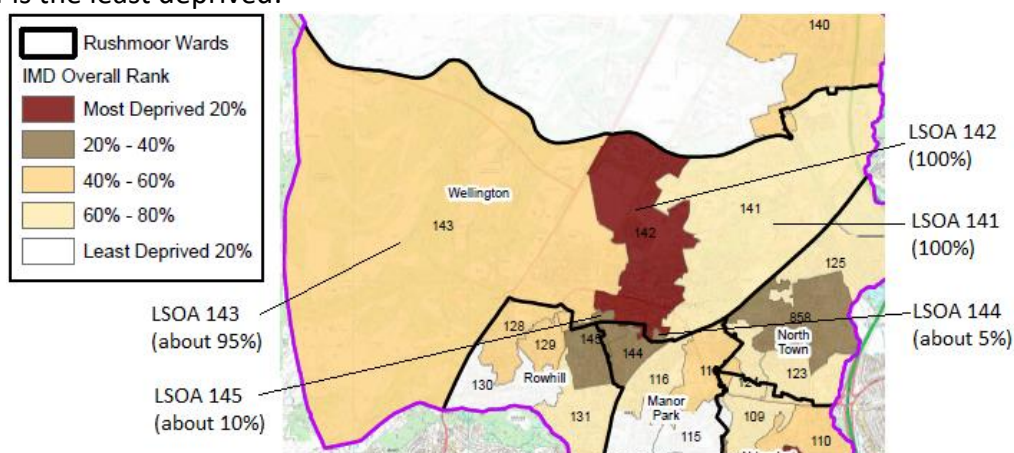

Deprivation breakdown

The Government's Index of Multiple Deprivation (IMD) 2019 provides a relative deprivation score for each small area in England, it covers a range of economic, social and housing issues. The overall score is calculated using data from seven domains. Most of indicator data has come from 2015 and 2016 and some of the data is from the 2011 Census. The Indices of Deprivation cover geographical areas that are called Lower-layer Super Output Area level (LSOA), of which there are 32,844 in the country. There are a total of 58 LSOAs in Rushmoor.

Unfortunately, LSOAs and the council's wards do not exactly line up. In Wellington ward there are all or part of five LSOAs. The following map shows the number of the LSOAs in Wellington ward and the approximate percentage of the LSOA in the ward. Each LSOA is ranked in order against all other LSOA in the country, where 1 is the most deprived and 32,844 is the least deprived.

LSOA 142 is in the 20% most deprived areas for Multiple Deprivation and for the Income, Crime and Barriers to Housing and Services domain. LSOAs 141 and 143 have a pocket of deprivation for the Barriers to Housing and Services domain. LSOA 145 (which is mostly in Rowhill ward) has pockets of deprivation for the Income and Crime domains. LSOA 144 (which is mostly in Manor Park ward) has a pocket of deprivation for the Income, Crime and Living Environment domains.
